Thank you to Chief Jerome and his entire department for all the work that went into the first ever CSI camp during the end of June. This was a great success and we're all excited to see how this event grows in the future. I'd also like to thank Chief Fletcher and everyone in the fire department. The last week of June saw the CSI Camp and a business resource class at the fire station and Chief Fletcher made sure the fire station was ready and able to accommodate both events, in between all the work going on along Market Street and Upper Lewisburg-Salem which has impacted the fire departments access ability for several months. We greatly appreciate everyone's work on making sure these events occurred without issue.

I'd also like to thank the Brookville Area Chamber of Commerce and the local SBA on putting together that first business resource class. This free class was about using AI technology to make your business more productive but wasn't as well attended as the sign ups indicated it would be. However, we're hopeful the next one on July 27, which topic is cyber security for small businesses, will be better attended. Interested small business owners can sign up by scanning the QR code available on the Chamber's and city's social media pages.

Quarterly utility bills will soon be hitting mailboxes, along with the quarterly newsletter insert. Please be on the lookout for these items. The quarterly newsletter insert will also be available in the city lobby and throughout the city.

The next Age Friendly Lunch and Learn is scheduled for next Wednesday, July 15. The guest speaker is Capt. Ferguson from the Brookville Fire Department. He'll be discussing fire and personal safety for seniors. And July's Third Thursday event will be next Thursday, July 16, 5-8 pm at Gruenig Park and Market Street. Brave Church will once again be hosting the free Kids Zone.

Subject: Finance Report

- I received our health insurance renewal rates without going to market and Anthem came back with a 28.57% increase and due to the significant increase we decided to complete FormFire and go to market. Anthem came back from market with an increase of 21.7%. Due to this significant increase we decided to look at other provider options for coverage while still maintaining similar coverage. After reviewing all the other options provided in the market review. We decided that moving to United Healthcare will provide the best benefits with an increase still within our budget. The move to United Healthcare will drop our increase for Health Insurance to 10.9% while still being able to provide 2 options to our employees, both an Embedded and Non-Embedded HSA plan. The City will continue to fund 85% of the monthly health insurance premium with the employee contributing 15% of the monthly premium.
- Our dental insurance was also up for renewal. We are currently with Anthem for Dental as well, but they came in at a 2.11% increase while Superior Dental came in with a 5.64% decrease since the coverage is very similar with Superior we believe moving forward with them is the best option. Dental insurance will remain 100% Employer paid.
- Our life insurance policy with Anthem Life is also up for renewal this year. Anthem came to us with a 0% increase, but several other providers came in with significant decrease in rates for the same or better coverage. Due to this we believe moving forward with Hartford for Life/AD &D and Vol Life /AD&D makes the most sense with a 36.8% decrease. As the employer we pay 100% of Life/AD&D with the employee having the option to add voluntary Life/AD&D at their cost.
- Our Vision insurance is also up for renewal. We are currently enrolled with Anthem for vision insurance and they came back with the lowest renewal at 0% for vision. Vision is 100% employee paid.

I am requesting council approve the renewal under the United Healthcare Plan, which allows the City to offer dual health insurance plans, with the employee contributing 15% and the employer contributing 85% of the monthly rate. The City will contribute \$1,000 for each single employee and \$2,000 for an employee and dependent contract under the United Healthcare HSA plans; and to renew our dental

insurance with Superior Dental, or Vision Insurance with Anthem Blue View and our Life/AD&D and Voluntary Life/AD&D with Hartford. The overall change for all these changes is approximately 9.73% which is keeps us within our Budget for 2026.

ORDINANCE 2026-07

AN ORDINANCE AMENDING THE CODE OF ORDINANCES PART 9, TITLE 3, SECTION 935.15 (a), FIXING THE TAPPING PERMIT FEES FOR SEWER SERVICE INSTALLED IN THE CITY OF BROOKVILLE, OHIO.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BROOKVILLE, OHIO, THAT:

SECTION I: Section 935.15 (a) of the Code of Ordinances is hereby amended to read as follows:

For all connections to the sanitary sewer system, the fee shall be in the amount for the respective uses shown below, but in no case less than two thousand dollars (\$3,000).

Residential	Fee
Single-family residence	\$3,000.00 per residence
Multi-family residence	\$4,000.00 for first 2 units plus \$400.00 for each additional unit

Nonresidential	Fee
Commercial, Industrial, Institutional, Schools, Governmental	\$3,000.00 plus \$.35 per sq. ft.

The tapping permit fees, per the above schedule, will go into effect for permits pulled after September 1, 2026.

SECTION II: This Ordinance shall revoke and rescind all Ordinances, and parts of Ordinances and Resolutions, and parts of Resolutions that are in conflict herewith and shall be enforced from and after the earliest period allowed by law.

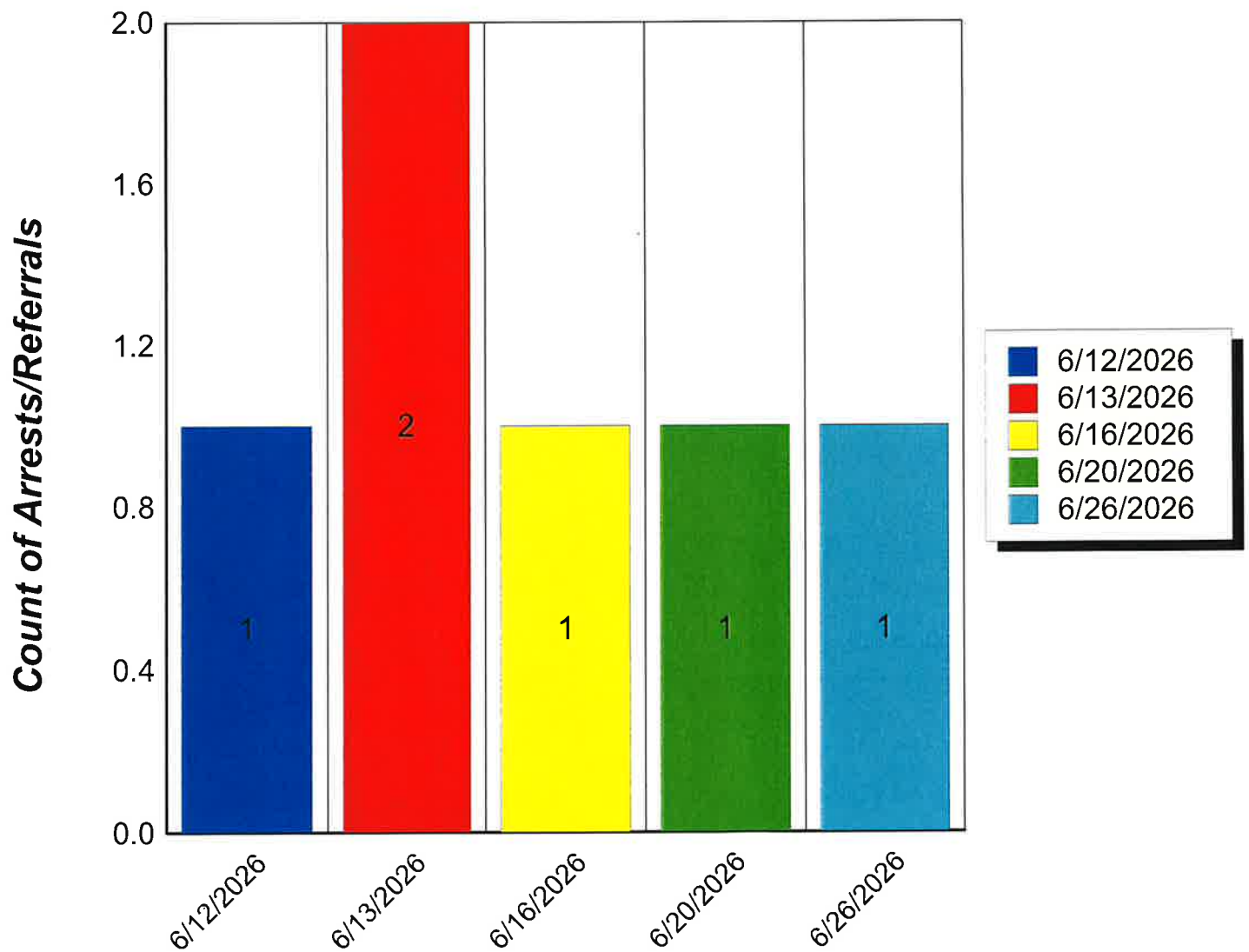

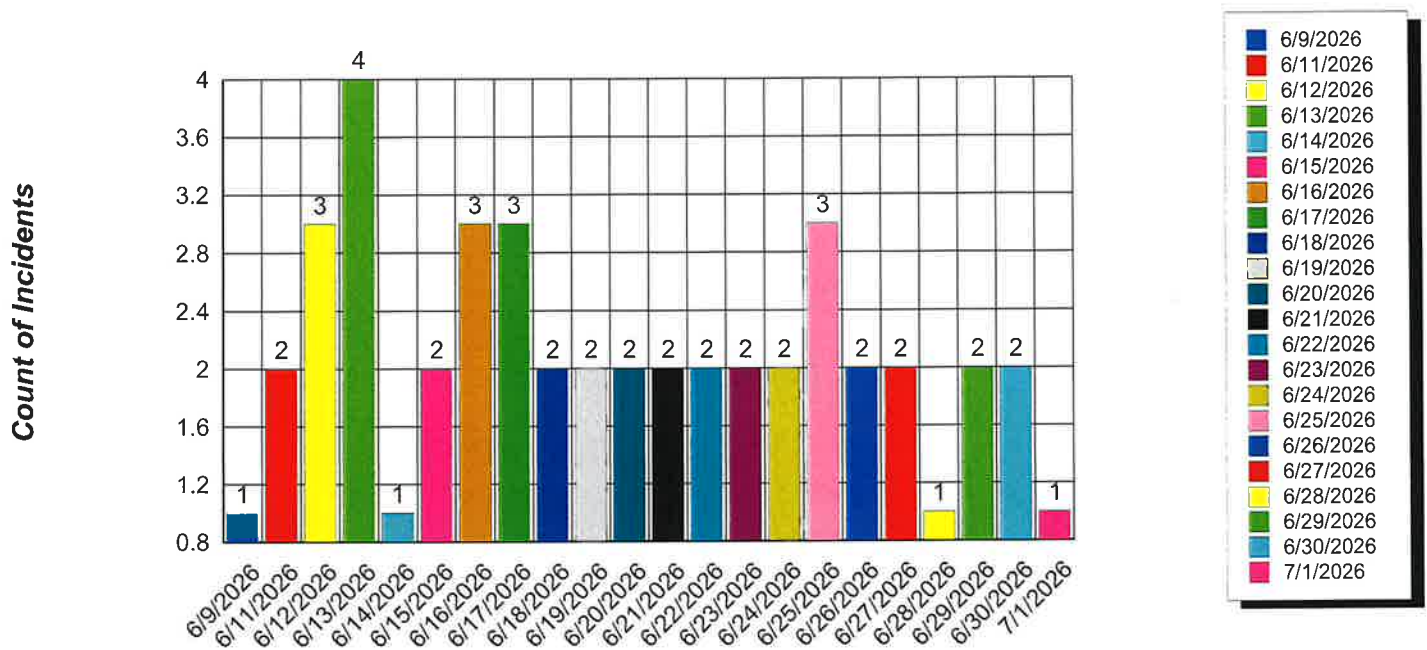
