An additional tax for the benefit of the City of Brookville for the purpose of **general construction, reconstruction, resurfacing, and repair of streets, roads, and bridges** at a rate not exceeding 3.85 mills for each one dollar of valuation, which amounts to \$0.385 for each one hundred dollars of valuation, for 5 years, commencing in 2021, first due in calendar year 2022.

Election Day Voting

- The first Tuesday following the first Monday of May except for the Presidential Primary which is held in March
- Polls open 6:30 a.m.
- Polls close 7:30 p.m.

Early in-person voting

- Begins 29 days prior to the election and ends the day before the election at 2:00 p.m.

Absentee voting by mail

- Begins 29 days prior to the election
- Must be postmarked the day before the election or hand delivered to the MCBOE by 7:30 p.m. on the day of the election

Project Updates:

- Johnsville-Brookville Sanitary Crossing – Work will begin on March 16 and should last 7-10 days, weather permitting. Detour signs have been posted, Brookville Schools were notified of the detour, and info posted on our Facebook and website.
- Hay Avenue Roadway Improvements and Walnut Street Waterline Replacement Project – Engineering and surveying work has begun on both projects. Work cannot begin until after July 1, 2021.
- The Mitigation Grant for 306-312 S. Wolf Creek Street is complete. Hydroseeding of the lot was completed on March 4. Work will begin soon on the second Mitigation Grant that was approved for 320 S. Wolf Creek Street.
- The USDA Wolf Creek Tree Removal Project – The drawings and specs for this project is hopefully in final review. They are also waiting on Ohio EPA approval for clearance for the proposed low flow stream crossing.
- Our Permissive Tax Project Application was recently approved for repaving of E. Westbrook Road from Wolf Creek Street to Albert Road.
- Golden Gate Park Walking Path-CDBG Project – Engineering is wrapping up and we hope to advertise for bids soon.
- No new updates on the SRTS Project, which is scheduled for 2022.

Reminder of our Annual Community Park Cleanup Day scheduled for Saturday, March 27 from 10:00 a.m. to noon. Supplies will be available at Shelter #4.

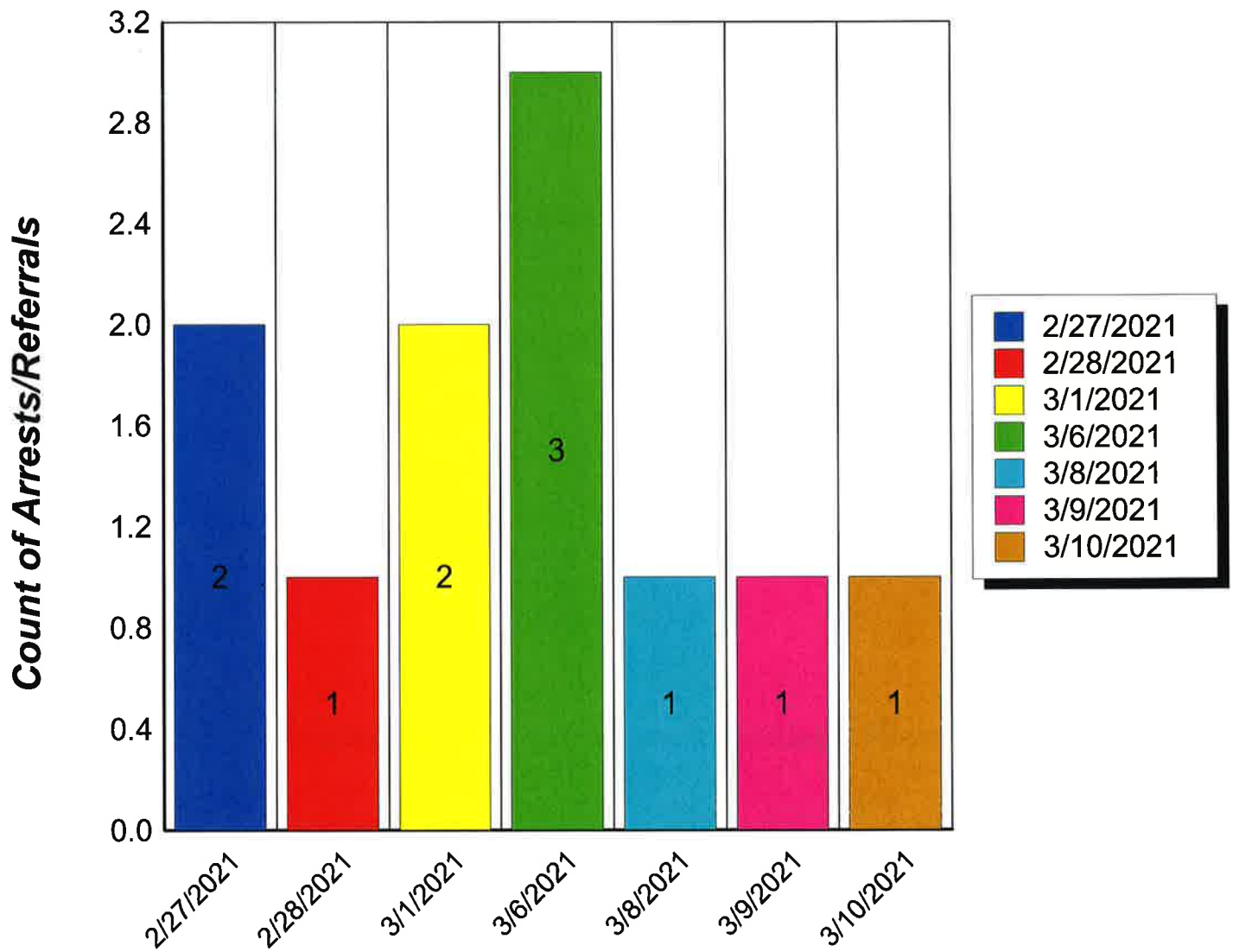

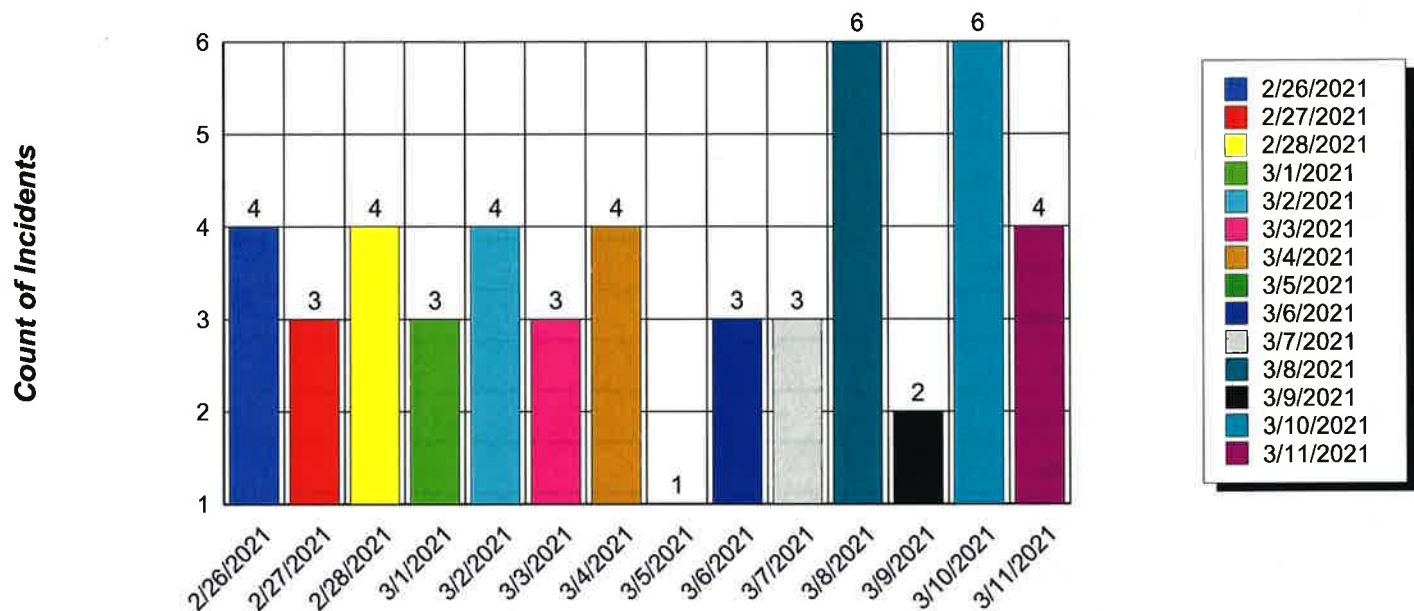
